



## AGREEMENT

This agreement is with Waterfall Ranch Outfitters LLC hereafter referred to as WRO and \_\_\_\_\_, hereafter referred to as our customer. This agreement is in effective when WRO has received your deposit. Prior to your hunt you will be asked to sign this agreement, the medical and physical condition release form, assumption of risk and release of liability form and another forms as determined by our attorney. You will have confirmed you have been read, reviewed and signed by the customer.

WRO agrees to:

1. Be insured as required by the state registration/licensing authority and the United State Forest Service.
2. Provide our client with a hunting trip from \_\_\_\_\_ to \_\_\_\_\_. The dates may change for reason outside of WRO's control including weather, government action or illness.
3. WRO has provided our customer with a list of suggested clothing and gear.
4. WRO will provide information and training about rules and regulations related to camping and hunting in the San Juan National Forest, as well as safety information about guns.
5. WRO will assist you with the processing and shipping of your meat and antlers.
6. WRO will provide the following services:
  - Base camp accommodations to include food, a cook, tent lodging, toilet facilities, and necessary supplies and equipment.
  - Guide service consists of one guide for each two hunters
  - Complete packing service for client's gear.
  - Riding horses and equipment selected by WRO with our customer's approval.
  - Wrangler services for horse care, game care and camp chores.
  - Field dressing, capeing and transporting of game.

Our customer agrees to the following:

1. Pay all fees and furnish all required information.
2. Live and camp in a manner consistent with the laws of Colorado, DOW regulations and USFS rules and regulations and WRO camp culture.
3. Be in good enough physical condition to be able to participate in any activity involved with our hunting experience.
4. Complete the medical release form and the assumption of risk and release of liability form.
5. Our customer understands and agrees the risk of back country camping, horseback riding, hiking, and hunting could present significant risk of serious injury including death.
6. WRO expects you to refrain from consuming any alcoholic beverages during the day and otherwise until all firearms associated with the hunt are unloaded and stored for the day.

Our fee is \$4500.
